#### Varanasi: The Holy City of India

Varanasi is a major religious hub in India, it is the holiest of the seven sacred cities (Sapta Puri) in Hinduism and Jainism, and played an important role in the development of Buddhism and Ravidassia. Buddha is believed to have founded Buddhism here around 528 BCE when he gave his first sermon, "The Setting in Motion of the Wheel of Dharma", at nearby Sarnath. The city's religious importance continued to grow in the 8th century, when Adi-Shankaracharya established the worship of Shiva as an official sect of Varanasi. During the Muslim rule through Middle Ages, the city continued as an important center of Hindu devotion, pilgrimage, mysticism and poetry which further contributed to its reputation as a center of cultural importance and religious education. Tulsidas wrote his epic poem on Rama's life called Ram Charit Manas in Varanasi. Several other major figures of the Bhakti movement were born in Varanasi, including Kabir and Ravidas. Guru Nanak visited Varanasi for Maha Shivaratri in 1507, a trip that played a large role in the founding of Sikhism. Annie Besant founded the Central Hindu College, which later became a

foundation for the creation of Banaras Hindu University in 1916. Besant founded the college because she wanted "to bring men of all religions together under the ideal of brotherhood in order to promote Indian cultural values and to remove ill-will among different sections of the Indian population. Banaras Hindu University is an internationally reputed temple of learning, situated in the holy city of Varanasi. This Creative and innovative university was founded by the great nationalist leader, Mahamana Madan Mohan Malviya, in 1916 with cooperation of great personalities like Dr Annie Besant, who viewed it as the University of India. Varanasi lies along National Highway 2, which connects it to Kolkata, Kanpur, Agra, and Delhi, and is served by Varanasi Junction railway station and Lal Bahadur Shastri International Airport. Varanasi is located at an elevation

of 80.71 meters (264.8 ft) in the center of the Ganges valley of North India, in the Eastern part of the state of Uttar Pradesh, Silk weaving is the dominant industry in Varanasi. The city is known throughout India for its production of very fine silk and Banarasi saris, brocades with gold and silver thread work, which are often used for weddings and special occasions. Tourism is Varanasi's second most important industry. The peak tourist season falls between October and March. Apart from the 19 archaeological sites identified by the Archaeological Survey of India including Sarnath and other Budhist places of worship, some of the prominent places of interest are the Kashi Vishwanath Temple, the Sankat Mochan Hanuman Temple, the Mahatma Gandhi Kashi Vidyapith, the Ramnagar Fort, the River front Ghats, the Tulsi Manas Temple.
