Apologies were received from Dr. B. R. Gaikwad, Mr. Ashwani sharma, Mr. S. K. Roy, Mr. Satish Vasudeo Khadke, Mr. Ashok Mahindru, Dr. Sibdas Bandopadhaya, Dr. S. S. Kaki, Dr. Prasad Nabar, Dr. Sanjit Kankjilal, Dr. R. P. Singh and Dr. B. V. S. K. Rao

Dr. Rajeev Churi, Vice President, HQ, welcomed all AGM members & invitees in the AGM meeting and addressed the AGM meeting organized in hybrid mode due to COVID 19 pandemic. The Vice President confirmed the requisite quorum and called the meeting to order. The agenda items were read out by H. S. Sharma, Honorary General Secretary (HQ) as per the Notice circulated amongst the members and were taken up for deliberation and necessary action by the members present accordingly.

**1. To approve the minutes of the last AGM held on 08-11-2020 through online.**

The minutes of the last AGM were circulated to all the CEC members along with the annual report by e-mail. It was also circulated during AGM to members for discussions. After discussion minutes were approved by AGM.

**2. To approve the action taken report on various decisions of last AGM.**

Action taken report was presented by Hon. General Secretary, Mr. H. S. Sharma. After discussions, members expressed their satisfaction with action taken by the secretariat.

**3. To present and approve the annual report for the year ending March 31<sup>st</sup>, 2021.**

The annual report of the year 2020-21 was circulated to all the members by email and also the hard copy was distributed during AGM among members for discussions. The report was read and presented by Mr. H. S. Sharma, HGS. The report was approved on proposal of Dr. R. K. Trivedi & seconded by Mr. S. K. Solanki by AGM.

**4. To pass the consolidated audited statement of accounts and balance sheet of the HQ, Zones and central committees for the year ending 31<sup>st</sup> March 2021.**

The accounts & annual audited balance sheet for 2020-21 for HQ & consolidated Balance Sheet were presented by HGT Mr. Rajesh Kumar Srivastava. Dr. Rajeev Churi pointed out the entry of Rs. 12,02,262.00 amount w/off a/c FARE Lab balance in the NZ consolidated balance sheet head of income and desired its clarification from NZ. It is decided to write a letter to NZ for clarification on the same issue. He further pointed out that, this amount might have been given advance by FARE Lab to NZ, as the seed money to conduct some events and was due to FARE lab.

After deliberation & discussions the same was approved by the AGM as proposed of Mr. P. K. Tewari & Seconded by Dr. Mahua Ghosh.

**5. To discuss and approve the budget of OTAI HQ for 2022-23 & review for 2021-22.**

The provisional budget for the year 2021-22 & 2022-23 was circulated to all the members for discussions. The budget was approved by AGM by incorporating suggestion given by CEC. CEC pointed out to make a provision for income &

expenditure pertaining to proposed 76<sup>th</sup> Annual Convention with a tentative income Rs. 20 Lakhs & expenditure of Rs. 18 Lakhs in the proposed budget of 2021-22.

**6. To appoint the auditors for 2021-22 and fix their remuneration.**

AGM approved as per recommendation of CEC appointment M/s Nivedita Associates as auditor of the association with remuneration of Rs. 13500 + GST/ annum (on last year remuneration).

**7. To consider the progress in respect of International Coordination Council (ICC), Research Investigation and Implementation Committee (RIIC), Publication Committee (PC) & JLST, Finance Committee, Coordination Committee and Web Committee.**

VP ICC, RIIC, FC were not present in the meeting & no information was received by HGS to present in the CEC. Dr. Pradosh Chakrabarti pointed out that RIIC needs to organize research activities, which is essential as per OTAI mandate / Statutory exemptions. Dr. Churi pointed out to update OTAI Annual report by mentioning the R&D activities conducted/supported by the association in order to avail the benefits under IT rules. As the OTAI has been supporting / organizing various research activities in the field by way of conducting numerous seminars, training courses & collaborative efforts between industry and research & academic institutes.

**PC/ JLST:** Dr. R. K. Trivedi informed to the members that the December 2020 and January 2021 was published & circulated to the members. The next two editions are also under process & it will release very soon.

**8. To discuss the resolutions received if any from any of the zones / committees. No Resolutions were received by the secretariat.**

No resolution was received. Dr. Churi suggested that a letter be send to Hon'ble VC of HBTU on occasion of centenary year celebration for very valuable contribution of HBTI /HBTU to our Association. Number of distinguished alumni of the institute have contributed to the growth of the OTAI. Also, the HQ activities and office building get all the support & help from the university. The letter will congratulate the Institute for completing glorious 100 years and supporting OTAI in all respects. National President will send a letter to Hon'ble VC HBTU in this regard.

## OTAI MERIT AWARDS

The names of awards are as follows:

### PROF. J. G. KANE MEMORIAL AWARD

This award was instituted by J. G. Kane Memorial Trust, Mumbai for an eminent scientist for his outstanding contribution in the field. The scientist selected by the OTAI, at the occasion of Annual Convention of OTAI held on 24/06/2022, delivers a lecture named professor J. G. Kane Memorial Lecture. The award carries a cash prize of Rs. 25000/= and a Citation which is jointly financed by J. G. Kane Memorial Trust & OTAI (WZ).

The award for the year 2021 was awarded to Prof. R. D. Kulkarni, Professor, Oils, Oleochemicals and Surfactants Technology Department, ICT, Mumbai. Dr. Kulkarni received the award in the inaugural session of the convention. Dr. Kulkarni delivered Dr. J. G. Kane Lecture.

### Dr. S. HUSAIN ZAHEER MEMORIAL AWARD

This award was instituted by Zaheer Science Foundation of the CSIR in the year 1979, to perpetuate the memory of Dr. S. Husain Zaheer, for excellence in research contribution in Oil Chemistry and Technology, Surface Coatings and allied subjects through research papers which include applicant's name among the authors and which appeared during the previous three calendar years. The award consists of cash prize of Rs. 10,000/= and a Citation.

The award for the year 2021 was awarded to Dr. P. K. S. Yadav, Assistant Professor, Department of Oil Technology, HBTU, Kanpur. Dr. Yadav received the award in the inaugural session of the convention held on 24/06/2022.

### S. D. THIRUMALA RAO MEMORIAL AWARD

This award has been instituted from the year 2003 in memory of Shri S. D. Thirumala Rao. This award is given for outstanding contributions (Papers published/Patents taken) during three calendar years preceding the year of award on the relevant subject. The award consists of cash prize of Rs. 10,000/= and a Citation.

The award for the year 2021 was awarded to Dr. Umesh Chandra Sharma, Assistant Professor, UIET, CSJM Kanpur University, Kanpur. Dr. Sharma was not present in the inaugural session of the convention, so their award was given to concern zone's representative.

Ltd. in memory of Late Mr. S.R. Bhatnagar for the post graduate students. The award is for excellence in the research in the field of Tribology / Lubricant and allied fields for the research papers published which include applicant's name among the authors which appeared during the previous or current calendar year.

#### **DR. SANTI NATH GHOSH MEMORIAL RESEARCH AWARD:**
